How to Sign Up

There is **only one way** to sign up and this is by completing the credit card authorization below and sending by fax **only to this secure fax number** - (303) 261-8374. The Monday night before the Tuesday webinar, by e-mail, we will send you the access code for the seminar as well as the outline. You may cancel your enrollment any time prior to Monday when we send the outline and receive a full refund. On the other hand, if you cancel after the outline has been e-mailed to you then only ½ of the tuition cost is refunded.

Time:

All seminars are at 1:00 p.m. Eastern time; 12:00 noon Central time; 11:00 a.m. Mountain time; and 10:00 a.m. Pacific Time.

Access to Webinar:

The access code to the webinar is sent on the Monday night prior to the webinar by e-mail. It is also sent a second time on Wednesday the day before the webinar by e-mail. If you have submitted your credit card authorization and have not received the access code by Tuesday mid-day, please send an e-mail to Zenny@InternationalCounselor.com. If you have not attended one of our webinars in the past or you are on a new computer, certain communication software needs to be downloaded onto your computer.
